Summary

Imports in Goods and Services:

Total value of imports of commodities had increased in 2009 by 3.9% compared to 2008 and amounted to US\$ 3,600.8 million compared to US\$ 3,466.2 million in 2008.

Regarding services from Israel, the total value reached US\$ 131.2 million with an increase by 37.9% compared to 2008. It is important to note in this context that both exports and imports in services are those collected from VAT vouchers only.

Exports in Goods and Services:

The total value of exports in 2009 reached US\$ 518.4 million reflecting a decrease by 7.2% compared to 2008 when the total value of exports was US\$ 558.4 million.

Total value of export of services to Israel was US\$ 123.0 million indicating a decrease by 2.8% compared to 2008.

Trade Balance:

The deficit in trade balance of goods amounted to US\$ 3,082.4 million in 2009 indicating an increase by 6.0% compared to 2008.

Services indicates a deficit of US\$ 8.2 million in trade balance with Israel in 2009 compared to a surplus in 2008 with US\$ 31.5.

Trade Partners:

Trade transactions in 2009 were with 144 countries. Israel represents 73.6% of the whole value of imported commodities, with a decrease by 5.1% compared to 2008. On the other hand, 87.5% of the whole value of commodities was exported to Israel, with a decrease by 9.2% compared to 2008.

The total value of imports from the European Countries in 2009 was US\$ 348.5 million, showing an increase by 55.8% compared to 2008; while direct exports to European Countries decreased by 41.6% in 2009 to reach US\$ 4.7 million compared to 2008.

The direct imports of commodities from Arab countries in 2009 increased by 22.5% to reach US\$ 92.0 million compared to 2008. Direct exports to Arab Countries in 2009 increased by 9.8% to reach US\$ 50.3 million compared to 2008. Direct exports to Jordan reached US\$ 28.9 million with a decrease by 15.4% compared to 2008.

Imports from the USA increased by 21.7% in 2009 to reach US\$ 40.3 million compared to 2008, while direct exports of commodities to the USA increased by 72.3% in 2009 to reach US\$ 6.1 million compared to 2008.

Chapter One

Introduction

The Foreign Trade Statistics with its three major indicators (imports, exports and trade balance) are considered vital requirements for the National Accounts and Balance of Payments. For these reasons, PCBS puts heavy emphasis on constructing a sound database for Foreign Trade Statistics in Palestine, and publishes a yearly report on the goods and services flowing to and from Palestine.

PCBS uses international recommendations in the compilation of Foreign Trade Statistics to ensure relevancy and comparability of its statistics to better serve all segments of users including international and civil society institutions as well as researchers and scholars.

1.1 Aims of the report

The report aims to provide statistics on:

- Imported and exported commodities distributed according to the country of origin and destination.
- The countries with which Palestine has commercial relations.
- Flow of goods according to the economic purposes.
- Flow of goods according to the means of entry and exit.
- Flow of goods according to the entry passages and borders.
- Flow of services according to the kind of service.

The mentioned statistics contribute to the calculation of relevant indicators including::

- The general net trade balance with partner countries.
- The per capita imports and exports.
- The commercial trade in services with Israel.

These indicators are necessary to serve:

- The preparation of national accounts, balance of payments, and other statistical programs.
- Research and economic analysis.
- Decision-makers and planners.
- International databases such as: UN, Arab League, ESCWA and others.

1.2 Report Structure

This report is divided into the following chapters:

Chapter One: Includes the introduction and aims of foreign trade statistics, and the report structure.

Chapter Two: Deals with basic concepts and definitions, measurement units and abbreviations included in the report.

Chapter Three: Presents the main results of the report

Chapter Four: Deals with the methodology in respect to data collection and coverage. It also deals with fieldwork activities for data collection, the methods of data processing and tabulation.

Chapter Five: Deals with data quality including statistical and non statistical errors.

Tables: The report includes 13 tables on the main indicators of Palestinian trade on goods and services.

Chapter Two

Concepts and Definitions

The Statistical Unit:

In Foreign Trade data, the statistical unit is considered by most countries to be the customs declaration, that is, the customs statement issued from the general customs department of countries with all of its enclosures, such as: the certificate of origin, the invoice, the packing list, the health certificate for medicines, food stuff and meat, the agriculture certificate and the release certificate, etc.

However, in Palestine, the clearance voucher of the value added taxation, the Israeli customs statement and other complementary data are considered the statistical unit in the Foreign Trade report. This was necessary due to the special situation in Palestine where border crossings is controlled by Israeli Authorities.

The Clearance Voucher for the Value Added Tax:

This is a unified invoice for both Israeli and Palestinian parties. Data includes the name of the licensed entity from both parties, the taxation number; the exchanged material with its type and value, the invoice number and the value added taxation. This shows the movement of trade exchange between the Palestinian Territory and Israel only.

Custom Declaration:

This is an Israeli document containing all the data related to Palestinian direct imports from other countries through the Israeli entries and ports, in addition to Damyah Bridge, Rafah and Allenby Bridge. A photocopy of the statement which represents direct imports to the Palestinian National Authority arrives to the Ministry of Finance but without enclosures since the Palestinian customs statement is partially applied in order to control the data of passengers entry from Jordan and Egypt only.

The Certificate of Origin:

This is a document issued by the Chambers of Commerce in the governorates and certified by the Ministry of National Economy and reflects data on exports of national origin and re-exported goods to Jordan and the Arab states and other countries of the world except Israel, in addition to the certificate of origin for the European Partnership issued by the Directorate General of Customs and reflecting Palestinian exports of national origin to European countries .

Imports:

Whole commodities (goods) that entered the country by air, land and sea that are used in consumption, convertibility through the manufacturing sector, and re-exportation.

Exports:

Whole commodities (goods) that are exported or re-exported outside the country, conditioned with ownership transcription to another economy, or to free customs regions.

Trade Balance:

The difference between Exports and Imports

C.I.F – Cost, Insurance and Freight:

Cost of the imported goods plus the cost for loading, transportation, and insurance within the exporting country plus the cost of the transport from the border or port of the exporting country to the border or port of the importing country.

FOB – Free on Board:

It refers to the total cost of exported goods plus the cost for transportation within the country of dispatch including possible loading cost in the port of dispatch.

Registered:

Includes actual data received from official sources only.

Main Results

3.1 Imports and Exports of Goods by Year

Slight increase in imports with a decrease in exports

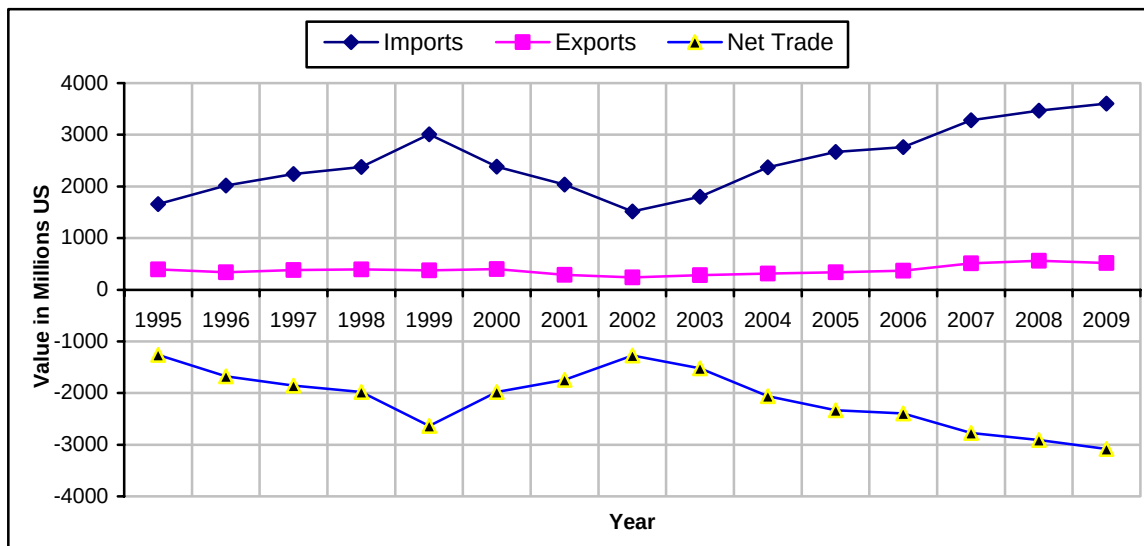
The total value of imports of goods in 2009 increased by 3.9% to reach US\$ 3,600.8 million compared to 2008. Exports of goods decreased by 7.2% to reach US\$ 518.4 million compared to 2008.

An increase in trade deficit and trade volume

The deficit in net trade balance in goods increased by 6.0% in 2009 to reach US\$ 3,082.4 compared to 2008.

Transaction Trade in 2009 increased by 2.3% compared to 2008.

Figure 1: Distribution of Imports, Exports in Goods and Net Trade Balance in the Palestinian Territory, 1995 - 2009

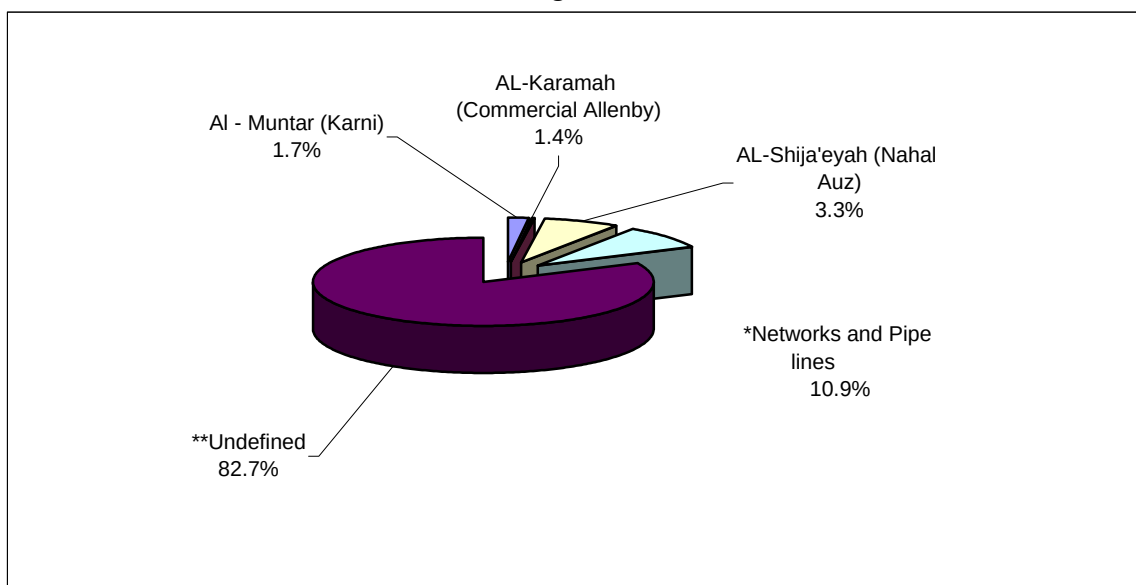


3.2 Imports of Goods by Entry Passage in 2009

Most of commodities was imported via undefined passage

Imports of the West Bank from Israel or other countries represents 82.7% of total imports in 2009, with an increase by 8.9% compared to 2008. As for Gaza Strip, 1.7% of commodities were entered via AL-Muntar passage and decreased by 14.4% compared to 2008. 3.3% of commodities were entered via AL-Shija'eyah passage and shows a decrease by 52.8% compared to 2008.

*Including Water and Electricity only.

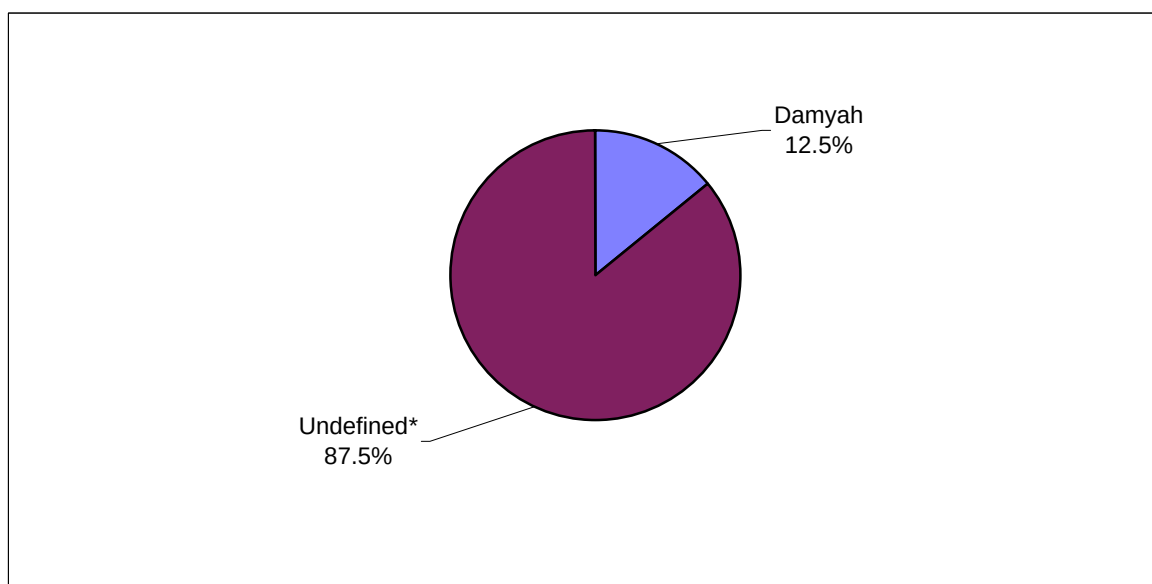
**Including Trade Transactions between West Bank and Israel, or imported goods from other countries through Israel.

3.3 Exports of Goods by Exit Passage in 2009

The majority of goods exported via undefined passage

Palestinian registered goods via undefined passage represents 87.5% of exports in 2009. Exports to Israel indicated a decrease by 9.2% compared to 2008. Other commodities were exported via Damyah passage to other countries.

Chapter Four

Methodology

The main objective of Palestinian External Trade Statistics is to monitor actual flows of goods and services during a reference period. Due to the political and economic conditions of the Palestinian Territory, PCBS has used VAT vouchers from the Ministry of Finance as a major source of data on trade exchange with Israel, in addition to other official sources related to external trade with the rest of the world, as mentioned in the first part of this report.

4.1 Field Operations

As mentioned, PCBS uses several data sources for calculating trade statistics such as:

Value Added Taxation Vouchers:

By using special forms, a specialized technical team from PCBS dealt directly with vouchers at the Ministry of Finance where goods and services with Israel are collected and transferred to the headquarters of PCBS for processing.

Customs Data:

PCBS uses the data provided by the General Administration of Customs and Asycuda project for covering trade with countries abroad (direct imports) via Israeli ports and airports. The data is transferred to the PCBS in electronic format broken down by Israeli customs tariffs in addition to the value, quality and country of origin. The files distributed by sections, chapters and main groups of H.S in addition to H.S 6 digit tables.

Besides the VAT vouchers and the Customs declarations data, which are the main sources, there are other types of data sources for the Foreign Trade Statistics in Palestine including:

- The Ministry of National Economy
- The Palestinian Water Authority
- The General Petroleum Corporation
- The Ministry of Agriculture
- The Ministry of Telecommunications and Information Technology

4.2 Data Processing

Office operations for foreign trade data can be summarised in three phases as follows:

- Data documentation
- Coding and data validation using H.S and correspondence tables for International classifications
- Tabulation phase using Access and Excel software for preparing goods and services tables

Data Quality

5.1 Accuracy of the Data

Statistical Errors

PCBS collects foreign trade data in accordance with international standards, where access to data is based on the official administrative records of various data sources, and consequently the data is not affected by statistical errors.

Non-Statistical Errors

Errors that can occur due to the statistical nature of the work at the Directorate of VAT, such as clearing bills that focus on the fiscal side only, resulting in shortages in other aspects such as the measurement of the quantities (weight and number), and non-billing breakdown by commodity. This lack of information has been overcome through the following :

1. Audit traders and professionals licensed by the Directorate of VAT.
2. Accountants audit - through auditing offices - which provides invoices of persons engaged with the Directorate of VAT, in collaboration with the Directorate.
3. District office audit of VAT for error correction, if any, to improve performance.
4. Audit of the Ministry of National Economy to correct any errors in the data in terms of the certificates of origin breakdown of commodities and price adjustment if illogical unit prices found.
5. Providing data entry program with three checks to address errors resulting from data entry mistakes.

5.2 Comparison of the Data

Comparison of data of this report with the published data from other sources, mainly:

1. Mismatches of data between different mechanisms for the collection and processing of data from each data source due to the different methodology
2. Published figures on imports and exports by partner countries might be different due to the methodology or the applied trade system.

5.3 Technical notes

Users of this report are advised to take the following technical notes into account:

1. The value of imports and exports published in this report do not include VAT.
2. Data were calculated on the basis of oil derivatives, the average sale prices of power distribution for these derivatives, and the monthly level of the General Petroleum Corporation, after deducting a percentage for the profit margin and VAT.
3. Statistics on commodity imports and exports is used in the preparation of the trade accounts, the rate of contribution of imports and exports of GDP. These indicators are actual and based on official documents without any estimates.
4. Imports and exports do not include smuggling of goods across crossings to the Palestinian Territory
5. Imports and exports of goods do not include any non-appropriated documents in the trade exchange with Israel.
6. Imports and exports with Israel contain indirect imports and exports with the countries of the world, because of a country of origin or destination in the bill, and that means:
 - Palestinian imports from Israel are not necessarily originated in Israel, but Israel is the country of shipment of the goods.

- Palestinian exports to Israel include Palestinian exports to the countries of the world through Israel.
7. The data contained in this report does not include that part of Jerusalem governorate which was annexed by Israel in 1967.
 8. There are some minor differences in the totals of the values of the same variable between different tables due to the use of different software packages in the tabulation of results.
 9. The value of imports was calculated on the basis of (C.I.F) and the value of exports was calculated on the basis of (F.O.B).
 10. Imports and exports represent service trade with Israel service only.
 11. Figures of 2009 might be changed in the coming report for 2010.
 12. Financial data was collected by NIS, US \$ and JD, but it was converted and published in US \$.
